ORDER AMENDING LOCAL RULES 5003-1 AND 5005-1

In keeping with the Court's vision to function virtually without paper¹:

1. Local Bankruptcy Rule 5003-1 is amended to read as follows:

RULE 5003-1 CLERK - GENERAL/AUTHORITY

a. Maintenance of Files. The clerk of the bankruptcy court shall maintain the files of all bankruptcy cases and proceedings, whether assigned to a district judge or bankruptcy judge.

Reference: Fed. R. Bankr. P. 9001(1); but see Fed. R. Bankr. P. 8006, 8007.

b. Official Record. The official document of record is the electronic document stored in the court's database.

This rule is effective January 1, 2004.

2. Rule 5005-1 is amended to read as follows:

5005-1 FILING PAPERS - REQUIREMENTS


a. Date and Time of Filing. Any filing placed in the court's drop box before 8:00 am will be deemed filed at midnight the previous business day.

b. Filer's Duty to Review Scanned Image. The filer of a paper document shall review for accuracy the scanned image of the document within 60 days of the date of filing of the document. If no correction of the scanned image is requested by the filer within



60 days of the date of filing of the document, the image of the document will stand as stored in the court's database.

This rule is effective January 1, 2004.
