VIII. ADDITIONAL INFORMATION OR EXPLANATIONS. *(Indicate part of Report.)*

Part I (Positions): No. 4 -- Only heir and principal distributee was family member who died 28 May 2006, and therefore several assets that were still in the name of the 1999 probate were deposited into or transferred to the 2006 probate estate. See Part I, No. 6.

Part II (Agreements): (cont.) former co-shareholder in firm.

Part VII (Investments and Trusts): Nos. 10 and 11 (flat, Newmarket, England, together with associated rental receipts and expenditures account held by Elvin Estates): Flat transferred from estate heir to filer and one other family member in equal shares who continue to hold the property jointly. In consequence of the transfer and the resulting ownership status, half of the annual income is now attributable to filer in his personal capacity rather than all the yearly income being attributable to filer in his previous capacity as personal administrator of the estate of the deceased family member who had owned the property. On 6 January 2006 filer and family member were notified by e-mail from English solicitors that property had been transferred. Subsequently filer received a copy of the registration of the property in the names of filer and family member, showing that the transfer had been "registered" (somewhat akin to "recording" a transfer of a real estate interest in the county of location in a state in the United States) in January 2006. However, further inquiries by filer have disclosed that the transfer was likely effected in March 2005, albeit it was not until January 2006 that filer was notified of any aspect of the transfer (that aspect being that the transfer had occurred, not when it occurred). Filer is amending his CY2005 disclosure statement to include this information.

Part VII (Investments and Trusts): No. 12 (Mazda Miata): valuation based on "Blue Book".

Part VII (Investments and Trusts): No. 23 through 49: family member died 28 May 2006. Filer was subsequently appointed as personal representative in the New Mexico probate estate (the "(new) 2006 probate estate", so titled to distinguish it from the 1999 probate estate of another family member who died in 1999). In addition, filer became one of the co-trustees of the family member's Revocable Trust which became irrevocable on the date of death of the family member who died on 28 May 2006. Initial values of the 2006 trust and probate assets (lines 25 through 49) are from the date of death (28 May 2006). Substantial amounts of the securities in the probate and trust have been liquidated and the proceeds distributed to heirs and beneficiaries, while some amounts have been retained in the trust and probate estate bank accounts for payment of bills. The trust also held or identified assets held as community property or in JTWR0S with another family member; those assets have passed directly (assuming the assets needed to "pass" at all) to the other family member and are not further identified in this disclosure statement.

Part VII (Investments and Trusts): No. 46 (Visteon) -- values determined by consulting, on 05/15/2007, historical stock prices chart at Visteon website.

Part VII (Investments and Trusts): No. 48 (AT&T/Cingular) -- asset is apparently a debt in the amount of \$720 that AT&T/Cingular owes to probate estate; there is no stock owned.

Part VII (Investments and Trusts): No. 49 (Ford Motor Co.) -- this was a "rogue" dividend (i.e., filer could not initially figure out why the dividend continued to be paid despite the sale of the Ford Motor Company stock -- it turned out that there was a tiny fractional share of FMC stock that had not been previously known or accounted for [sort of like a random bit of DNA manifesting itself]) in the amount of four (4) cents per year; that is, one cent per quarter. In order to be able to resume deciding matters involving Ford Motor Company and Ford Motor Credit Company, filer immediately sold the asset to the attorney who is performing services for the 2006 probate estate and the trust and who graciously offered to accept a transfer of the asset immediately and take care of disposing of it to a non-minor family member.

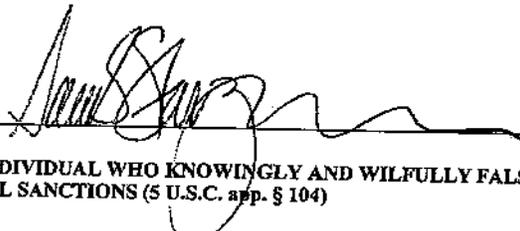
