NOTICE OF DEADLINE FOR OBJECTING TO SUPPLEMENT TO THE THIRD AND FINAL APPLICATION BY PEPPER HAMILTON LLP, FOR ALLOWANCE AND PAYMENT OF COMPENSATION FOR SERVICES RENDERED FOR THE PERIOD SEPTEMBER 27, 2001 THROUGH DECEMBER 14, 2001, FOR FINAL ALLOWANCE OF FEES AND EXPENSES PREVIOUSLY PAID OR ALLOWED AS INTERIM FEES AND EXPENSES, FOR EXPENSES FROM DECEMBER 15, 2001 THROUGH JULY 15, 2002, AND FOR ALLOCATION OF FEES AND EXPENSES BETWEEN PRE-TERMINATION CARVE OUT AND POST-TERMINATION CARVE OUT

On August 9, 2002, Pepper Hamilton LLP, counsel for the Unsecured Creditor's Committee, filed its Supplement to the Third and Final Fee Application ("Supplement"). Copies of the Supplement can be inspected at the office of the Clerk of the Bankruptcy Court, Federal Building and United States Courthouse, 421 Gold Avenue, SW, Third Floor, Albuquerque, New Mexico 87102, or may be obtained by contacting the office of the undersigned counsel.

In its Supplement, Pepper Hamilton LLP, as counsel for the Unsecured Creditor's Committee, requests that the Court grant final allowance of compensation for the Third Application Period (September 27, 2001 through December 14, 2001), as a priority, administrative expense, in the *reduced* amount of \$34,281.00, consisting of \$29,856.00 for professional fees, \$4,425.17 for reimbursable costs and expenses, and \$277.00 for gross receipts tax. Pepper Hamilton LLP also seeks reimbursement of expenses for the period December 15, 2001 through July 30, 2002 in the amount of \$6,554.15.

The Third and Final Application, along with the Supplement thereto, are on file with the Bankruptcy Court, and include an itemization of the services rendered and costs incurred during the Third Application Period. Pepper Hamilton's First and Second Interim Fee Applications, which also are on file with the Bankruptcy Court, include an itemization of the services rendered and costs incurred during the First and Second Application Periods.

If you object to the Supplement, you must file the original and one copy of your written objection with the clerk of the Court, United States Bankruptcy Court, 421 Gold Avenue, SW, Third Floor, Post Office Box 546, Albuquerque, New Mexico 87103-0546 **ON OR BEFORE THE DATE THAT IS TWENTY DAYS FROM THE DATE OF MAILING OF THIS NOTICE (plus three days because this notice was served by mail, for a total of twenty-three days)**, and must serve a copy of the objection on I. William Cohen, Pepper Hamilton LLP, 100 Renaissance Center, Suite 3600, Detroit, MI 48243.

If objections are timely filed, a hearing to consider any timely objections will be held before the Honorable James S. Starzynski, United States Bankruptcy Judge, District of New Mexico, on September 4, 2002, at 11:00 a.m. (mountain time). If no objections are timely filed, an order approving the Final Application will be presented to the Court for entry without a hearing or further notice.
