**OBJECTION OF OFFICIAL COMMITTEE OF UNSECURED CREDITORS OF
FURR'S SUPERMARKETS, INC. TO APPLICATION FOR ORDER APPOINTING
ROBERT L. BERGER & ASSOCIATES, LLC AS CLAIMS, VOTING AND NOTICING
AGENT OF THE BANKRUPTCY COURT UNDER 11 U.S.C. §156(C)**

The Official Committee of Unsecured Creditors of Furr's Supermarkets, Inc. (the "UCC") by and through its counsel Pepper Hamilton, LLP (Stuart Hertzberg, Esq. and I. William Cohen, Esq.), and local counsel Davis & Pierce, P.C. (William F. Davis, Esq. and Chris W. Pierce, Esq.), for its Objection, hereby states:

1. On February 8, 2001, Debtor filed a voluntary petition for relief under Chapter 11 of the Bankruptcy Code.
2. The "Application For Order Appointing Robert L. Berger & Associates, LLC as Claims, Voting And Noticing Agent of the Bankruptcy Court under 11 U.S.C. §156(c)" (the "Application") and the supporting affidavit, were filed on February 8, 2001.
3. The UCC objects on the grounds that it has not had sufficient time to examine the Application and determine whether grounds exist to deny the Application. The UCC is investigating the charges proposed for these services, and comparing costs as proposed by other firms, in order to determine whether grounds exist to deny the Application, but such investigations are not yet complete.
4. Further, the UCC believes that the services proposed to be provided, as described in Paragraphs 12 and 13 of the Application, are or may be outside the scope of 11 U.S.C. §156(c), and that it might be appropriate to treat such services as professional services, subject to Court review


after notice and a hearing. The UCC further believes that the invoices described in Paragraph 15 should be provided to the UCC as well.

5. Therefore, the UCC objects to the Application, and reserves any and all of its rights, claims and objections, pending the outcome of its investigations.

WHEREFORE, the Committee requests that the Court deny the Application for Order Appointing Robert L. Berger & Associates, LLC as Claims, Voting and Noticing Agent of the Bankruptcy Court Under 11 U.S.C. §156(C) pending the outcome of its investigations, and for such other and further relief as the Court deems just.


