**ORDER RESULTING FROM INITIAL PRETRIAL CONFERENCE ON CONTESTED
MATTER INVOLVING ADMINISTRATIVE CLAIM OF TGAAR PROPERTIES**


This matter came before the Court for an initial pretrial conference on September 4, 2002 on the contested matter commenced by TGAAR Properties, Inc.'s ("TGAAR's") Motion for Payment of Administrative Expenses, filed on or about August 20, 2002 and docketed as #1807, and the objection thereto filed by the Chapter 7 Trustee. Counsel for the parties are listed below.

IT IS ORDERED that the deadline for completion of discovery shall be January 6, 2003. By "completion of discovery" the Court means that requests should be served on opposing counsel in sufficient time for the answers to be due on or before the discovery deadline as measured by the times allowed in the Federal Rules of Bankruptcy Procedure or as otherwise specifically ordered by the Court.

IT IS ORDERED that the Court will conduct a final pretrial conference on January 7, 2003 at 9:00 a.m. MST in the Second Floor Conference Room, 421 Gold Ave. SW, Albuquerque, NM.


Prior to the pretrial conference, the parties shall have conferred with each other and shall provide the following information to the court at the pretrial conference: (1) identification of factual and legal issues, (2) time estimate for a final hearing, if necessary, (3) likelihood of resolution of the matter(s).
