
In its Final Application, Chanin Capital Partners, LLC, as investment bankers to the Unsecured Creditors' Committee requests that the Court grant final allowance of compensation for the period of May 17, 2001 through August 17, 2001 (the "Compensation Period"), as a priority, administrative expense in the amount of \$328,977.26, consisting of \$300,000.00 for professional fees and \$28,977.26 for reimbursable costs and expenses.

The Final Application includes an itemization of the services rendered and costs incurred during the Compensation Period.

If you object to the Final Application, you must file the original and one copy of your written objection with the Clerk of the Court, United States Bankruptcy Court, 421 Gold Avenue, SW, Third Floor, P.O.
