
ORDER ON MOTION OF FURRS 4, 5, 7 & 9 LLCs
FOR PAYMENT OF ADMINISTRATIVE EXPENSES

THIS MATTER came before the Court for final hearing on the motion of Furrs 4 LLC, Furrs 5 LLC, Furrs 7 LLC and Furrs 9 LLC (collectively, "Movants"), for an order pursuant to 11 USC 365(d)(3) allowing administrative expense treatment of amounts accrued for post-petition rent and taxes due and owing up to the date of rejection under leases of nonresidential real property. The Court is advised that the Debtor does not contest the amounts stated.

IT IS THEREFORE ORDERED that Movants be and are entitled to Chapter 11 administrative expense treatment of the following amounts that have come due and payable post-petition under leases for non-residential real property with the Debtor and which leases were rejected by the Debtor.


