ALLOWANCE OF LATE FILED ADMINISTRATIVE CLAIM**

On January 3, 2003, Floho Partners ("Floho"), a creditor herein, by and through its attorneys, Kronish Lieb Weiner & Hellman LLP (James A. Beldner, Esq.) filed its Application to Have the Administrative Claim of FLOHO Partners Deemed to Have Been Filed Within the Administrative Claim Bar Date Pursuant to Section 105(a) of the Bankruptcy Code and Rule 9006(b) of the Federal Rules of Bankruptcy Procedure (the "Application"). Beldner, Esq., Kronish Lieb Weiner & Hellman LLP, 1114 Avenue of the Americas, New York, NY 10036. If any objections are timely filed, a hearing will be held on notice only to Floho and the objecting party. If no objections are timely filed, an order granting the Motion will be presented to the Court for entry without a hearing or further notice.**
