**FIRST INTERIM APPLICATION BY ATTORNEYS FOR
CHAPTER 7 TRUSTEE THE FOR ALLOWANCE AND PAYMENT OF
COMPENSATION FOR THE PERIOD OF FEBRUARY 2002 TO APRIL 30, 2003**

The law firm of Davis & Pierce., P.C. ("Attorneys"), Counsel for the Chapter 7 Trustee, submits this application for allowance and payment of compensation pursuant to Bankruptcy Code §§330 and 503.

In support of this Motion, Attorneys state:

1. First Application Period, Amount of Compensation Sought and Already Paid. In this First Fee Application, Attorneys seek allowance and payment of compensation for services rendered and costs incurred between February 2002 through April 30, 2003 (the "First Application Period") in the total amount of \$355,896.01, consisting of \$327,017.50 for fees, \$9,870.33 for reimbursable costs and \$19,008.18 for gross receipts tax. As authorized by the Order Approving the Motion to Employ Attorneys, the Chapter 7 Trustee has paid Attorneys' invoices for services rendered in the First Application Period in the total amount of \$198,393.89. A balance of \$70,995.71 plus the 25% holdback of \$86,506.41 totals \$157,502.12, was still owing during the Application Period. \$31,254.76 was received after the Application Period for a net amount owed of \$126,247.36.

2. Commencement of the Bankruptcy Case. On February 8, 2001, the Debtor filed a voluntary petition for relief under Chapter 11 of the Bankruptcy Code. An order for relief on the petition was entered the same date as a matter of course. On December 19, 2001, the Debtor converted the case to a Chapter 7 case, and the Trustee was appointed.

3. Trustee's Employment of Davis & Pierce, P.C. ("Attorneys"). On December 21, 2002, the Trustee filed its Motion to Employ Davis & Pierce, P.C. as her counsel. On July 3, 2002, the Court entered the Order Granting Trustee's Motion to Employ Davis & Pierce, P.C. as Counsel for the Trustee (the "D&P Employment Order"), approving the Trustee's employment of Attorneys effective as of the Conversion Date. The Trustee retained Attorneys to represent the Trustee in all matters and proceedings in which the Trustee required bankruptcy counsel, and in such other matters as the Trustee may request of Attorneys and Attorneys may agree to perform outside the bankruptcy area. Pursuant to the D&P Employment Order, the Trustee was authorized to pay Attorneys' billing statements, prior to the Court's determination of the allowability of Attorneys' compensation, up to and including 75% of fees, and up and including 100% of reimbursable costs and applicable gross receipts tax, subject to ultimate approval of the paid compensation.

4. Prior Fee Applications by Attorneys; Prior Compensation Received. This is Attorneys' first application for compensation with regard to its representation of the Chapter 7 Trustee. Attorneys have received \$198,393.89 during this First Period which is reflected in the Application and has been credited to the amounts sought herein. Attorneys received \$31,254.76 after the Application Period for services performed during the Application Period. Pursuant to Bankruptcy Code §331, Attorneys have not applied for allowance of compensation in the preceding 120 days.

5. Services Rendered Were Actual and Necessary; Fees Charged are Reasonable. Following its employment by the Chapter 7 Trustee, Attorneys have represented the Trustee since her appointment. The services rendered and the costs and expenses incurred by Attorneys on behalf of the Chapter 7 Trustee during the First Application Period, for which compensation is sought, were actual and necessary. The amount charged for fees is reasonable based on the nature, extent and value of the services and the amount of time spent providing the services.

6. Itemization of Fees and Costs and Description of Services Rendered. The services provided by Attorneys in the First Application Period are set forth in detail on the billing recap attached hereto as Exhibit "A", which is incorporated herein by reference (the "Billing Recap"). The Billing Statements which itemize all charges for professional services, reimbursable costs and expenses and gross receipts tax, and setting out the hourly rates for each attorney and legal assistant employed by Attorneys who rendered services to the Chapter 7 Trustee and separately describe the services rendered and hours worked by each individual each day for each specific task performed during the First Application Period, and further itemize all expense charges; and, at the end of the Billing Statement, summarizes the total hours and total charges per individual. The Billing Statements have been scan to CD and are being provided along with this Application. Hard copies of the Billing Statements are available for reproduction upon request. Copies of Expense Receipts are also available for reproduction upon request. The accounting services, costs and expenses as set out in the Billing Statement are true and correct to the best of Attorneys' knowledge, information and belief.

7. General Description of Services Rendered on Behalf of the Chapter 7 Trustee. As more fully set out in the Billing Recap, in general, Attorneys' services rendered for the Chapter 7 Trustee during the First Application Period have included, among other things:

- A. Assisting the Trustee in conducting preference screens, and filing a large number of preference actions;
- B. Filing a number of adversary proceedings to recover accounts receivable and prepaid open accounts; and
- C. Assisting in the sale of certain liquor license.

8. Time Charged for Multiple Attorneys and Allocation of Responsibility. During the First Application Period, Attorneys worked a total of 1,876.4 hours of attorney time and 482.7 hours of legal assistant time for professional services rendered on behalf of the Chapter 7 Trustee. In billing time for

multiple attorneys and allocating responsibility, the Attorneys attempted to minimize duplication of effort and overlap of responsibilities.

9. Billing Rates, Time Billed and Rates for Other Charges. During the Final Application Period, the billing rates charged for attorneys and legal assistants were charged at Attorneys' normal and customary billing rates, or less, charged to clients other than the Debtor, as shown on the attached "Attorney and Timekeeper Rates and Time Allocation," (see attached Summary Sheets).

Attorneys, in accordance with its customary billing practices, also charged for costs and expenses, including \$0.25 per page for in-house photocopying, \$0.25 per mile for hand deliveries, \$1.00 per page for telecopies (outgoing only), and actual out-of-pocket expenses for other expenses such as travel and meals while traveling, hotels, taxis, tips, deposition transcripts, computer aided legal research, postage, long distance telephone and overnight mail.

10. Other Factors. Attorneys also support this First Fee Application with discussion of various other factors, as follows:

(a) Expertise and experience in the area of bankruptcy of the Attorneys rendering services to the Chapter 7 Trustee. The Attorneys have extensive expertise and experience in Chapter 11 bankruptcies, and enjoy a respected reputation in the legal community for their work in both bankruptcy matters and in general commercial litigation. Mr. Davis has a Certificate of Specialization from the New Mexico Board of Legal Specialization in Bankruptcy (Business) Law and a Masters in Business Administration. Mr. Pierce has a Certificate of Specialization from the New Mexico Board of Legal Specialization in Bankruptcy (Consumer) Law.

(b) Method used to compute time charges. Applicant billed hourly for its services for representation of client at normal, set, hourly rates for each attorney and timekeeper in the firm. The number of hours and hourly rates for each timekeeper who worked on representation of the client in this

proceeding are itemized in this application. The billing invoices reflect contemporaneous time entries which set forth the services performed, the dates on which such services were performed, the identity of the individual performing the work, and the time spent in tenth of one hour increments.

(c) Relative billing rates of Attorneys for in-court and out-of-court hours. The Attorneys bill the same rates for in-court and out-of-court hours. Travel time is billed at the normal hourly rate because Attorneys use travel time for review of pleadings, files and preparation for hearings or meetings. Layover time between flights is not billed unless specific legal work is being performed during the layover.

(d) Difficulty of case dealt with by Attorneys. This case is large, complex and difficult. Representation of the Trustee has made substantial demands upon the time and skills of Attorneys. Attorneys have turned away other work, and narrowed its client base, to have adequate time to represent the Trustee.

(e) Results Achieved and Benefit of the Results to the Estate. The Attorneys, as stated above, have dealt with varied aspects of this case. The Attorneys have worked in assisting the Trustee in conducting preference screens, and filing a large number of preference actions; and filing a number of adversary proceedings to recover accounts receivable and prepaid open accounts.

11. Services Rendered Solely for the Chapter 7 Trustee; No Fee Sharing Arrangement. All professional services for which allowance and payment of compensation is requested were performed by Attorneys for the Chapter 7 Trustee and not on behalf of the debtor or any other committee or person. Attorneys have not shared or agreed to share any compensation received or to be received by it for services rendered in or in connection with this case with any person except with employees of Attorneys in the ordinary course of business.

WHEREFORE, Attorneys respectfully request that the Court allow, as a priority, administrative

expense, the sum of \$355,896.01 for the First Application Period, consisting of fees for professional services rendered in the amount of \$327,017.50, compensation for expenses and costs in the amount of \$9,870.33 and gross receipts taxes in the amount of \$19,008.18. After application of the amount received of \$198,393.89, Attorneys are still owed \$157,502.12. A balance of \$70,995.71 plus the 25% holdback of \$86,506.41 totals \$157,502.12, which was still owing during the Application Period. \$31,254.76 was received after the Application Period for a net amount owed of \$126,247.36. Attorneys further request that the Court approve the prior payment and authorize the Debtor to pay Attorneys the entire unpaid balance for the First Application Period of \$126,247.36.
