**NOTICE OF DEADLINE TO OBJECT TO TRUSTEE'S MOTION TO APPROVE
SETTLEMENT OF ADVERSARY PROCEEDING No. 02-1188 S**

Yvette J. Gonzales, Chapter 7 Trustee (the "Trustee") hereby gives notice pursuant to Bankruptcy Rule 9019 that on June 18, 2003 she filed a Motion to Approve Settlement of Adversary Proceeding 02-1188 S (the "Motion") (Doc.#2124), asking Court approval of a settlement of adversary proceeding No. 02-1188 S, *Yvette J. Gonzales, Trustee v. H. J. Heinz Company* (the "Adversary Proceeding").

In the Adversary Proceeding, the Trustee sought to recover \$79,814.34 from H. J. Heinz Company (the "Defendant") for excess post-petition prepayments to Defendant and on account for funds owed post-petition but not paid by Defendant. The Trustee has agreed to accept payment in the amount of \$77,888.34 in full satisfaction of any and all claims asserted in the Adversary Proceeding, subject to approval by the Court. If the Motion is approved, the settlement will be consummated and the Adversary Proceeding will be dismissed with prejudice.

Any party who objects to the Motion must file its objection with the Clerk of the Bankruptcy Court, Federal Building and United States Courthouse, 421 Gold Ave. SW., Third Floor, Albuquerque, N.M. 87102 (or P.O. Box 546, Albuquerque, N.M. 87103), **within 20 days after the date of mailing of this notice, plus 3 days for service of this notice by mail, for a total of 23 days (or on or before July 21, 2003)**, and serve a copy of the objection on Thomas D. Walker (address given below). If any objections are timely filed, a hearing will be held on notice only to Mr. Walker and objecting parties. If no objections are timely filed, an order granting the Motion will be presented for entry without a hearing or further notice.
