**ORDER APPROVING SETTLEMENT OF

THIS MATTER came before the Court on the Chapter 7 Trustee's Motion to Approve Settlement of Adversary Proceeding 03-1112-S (Flowers Baking Co. of El Paso, Flowers Baking Co., d/b/a Flowers - El Paso). The Court, being sufficiently advised, hereby FINDS:

1. The Chapter 7 Trustee's Motion to Approve Settlement of Adversary Proceeding 03-1112-S (the "Motion") was filed on September 25th, 2003.


2. Notice of the filing of the Motion was mailed by first class United States mail, postage prepaid, on September 25th, 2003, to all persons listed on the limited matrix as set forth in the original Notice filed herein, and was sufficient and proper in the circumstances. The deadline to file an objection expired on October 20th, 2003, which includes three days for service by mail. No objections to the Motion were filed.

3. The Settlement should be approved.

4. Upon entry of this Order, Flowers Baking Co. of El Paso, Flowers Baking Co., d/b/a Flowers - El Paso will pay the sum of Thirty Four Thousand Dollars and no/100 (\$34,000.00) to

the Chapter 7 Trustee and the Adversary Proceeding will be dismissed with prejudice.

IT IS THEREFORE ORDERED that the Chapter 7 Trustee's Motion to Approve Settlement of Adversary Proceeding 03-1112-S is granted, and the settlement of Adversary Proceeding 03-1112-S is approved as set forth in the Motion.


