**NOTICE OF DEADLINE FOR OBJECTING TO SECOND INTERIM FEE APPLICATION OF
SAGE ACCOUNTING, SMALL/KEFAUVER CPA'S, P.C., ACCOUNTANTS FOR THE
CHAPTER 7 TRUSTEE**

On December 8, 2003, Sage Accounting, Small/Kefauver CPA's, P.C., accountants Yvette J. Gonzales, Chapter 7 Trustee ("Trustee"), filed its Second Interim Application for Allowance and Payment of Fees and Expenses (the "Fee Application"). A copy of the Fee Application can be inspected at the office of the Clerk of the Bankruptcy Court, Federal Building and United States Courthouse, 500 Gold Avenue, SW, Tenth Floor, Albuquerque, New Mexico 87102.

In the Fee Application, Sage requests fees for professional services and reimbursement of costs and tax for the period from August 1, 2002, through November 25, 2003, in the amount of \$90,694.95 for fees, \$142.47 for expenses, and \$5,279.92 for New Mexico gross receipts tax, for a total of \$96,117.34. Of this amount, \$71,191.26 has been paid, leaving a balance owing of \$24,926.08. The Fee Application requests Court approval of these amounts, that the Trustee be authorized to pay the remaining balance, either from funds of the bankruptcy estate or from funds held by the Trustee that are owned by the estate's secured lenders, as set forth in the settlement agreement between the Trustee and the secured lenders. The Fee Application includes an itemization of the services rendered and costs incurred.

If you object to the Fee Application, you must file the original and one copy of your written objection with the Clerk of the United States Bankruptcy Court, 500 Gold Avenue, SW, Tenth Floor, Post Office Box 546, Albuquerque, New Mexico 87103-0546, on or before 20 days from the date of mailing of this notice, plus 3 days for mailing, for a total of 23 days, **i.e., on or before December 31, 2003**, and must serve a copy of the objection on Rachel L. Kefauver, Sage Accounting, Small/Kefauver CPA's, P.C. at the address given below. If any objections are timely filed, a preliminary hearing will be held on the objection with notice to the objecting party and notice to trustee. If no objections are timely filed, an order approving the Fee Application will be presented to the Court for entry without a hearing or further notice.
