ORDER APPROVING SETTLEMENT OF ADVERSARY PROCEEDING 02-1110-S

THIS MATTER came before the Court on the Chapter 7 Trustee's Motion to Approve Settlement of Adversary Proceeding 02-1110-S (Packaged Ice, Inc., d/b/a Reddy Ice Corporation). The Court, being sufficiently advised, hereby FINDS:

1. The Chapter 7 Trustee's Motion to Approve Settlement of Adversary Proceeding 02-1110-S (the "Motion") was filed on December 2, 2003.


2. Notice of the filing of the Motion was mailed by first class United States mail, postage prepaid, on December 2, 2003, to all persons listed on the limited matrix as set forth in the original Notice filed herein, and was sufficient and proper in the circumstances. The deadline to file an objection expired on December 26, 2003, which includes three days for service by mail. No objections to the Motion were filed.

3. The Settlement should be approved.

4. Upon entry of this Order, the Defendant will pay the Trustee One Hundred Thirty Seven Thousand Seven Hundred One Dollars and 93/100 (\$137,701.93) upon the terms set out in the Motion and the Settlement Agreement between the parties. Upon

completion of the payments, the Adversary Proceeding will be dismissed with prejudice.

IT IS THEREFORE ORDERED that the Chapter 7 Trustee's Motion to Approve Settlement of Adversary Proceeding 02-1110-S is granted, and the settlement of Adversary Proceeding 02-1110-S is approved as set forth in the Motion.


