**ORDER APPROVING SETTLEMENT OF
ADVERSARY PROCEEDING 02-1106-S**

THIS MATTER came before the Court on the Chapter 7 Trustee's Amended Motion to Approve Settlement of Adversary Proceeding 02-1106-S (Morey's Seafood International, LLC). The Court, being sufficiently advised, hereby FINDS:

1. The Chapter 7 Trustee's Motion to Approve Settlement of Adversary Proceeding 02-1106-S (the "Motion") was filed on February 6, 2003. An Amended Motion to Approve Settlement of Adversary Proceeding 02-1106-S (the "Amended Motion") was filed on February 13, 2003. The Amended Motion was filed to correct an error contained in the title of the Motion.


2. Notice of the filing of the Motion was mailed by first class United States mail, postage prepaid, on February 6, 2003, to all persons listed on the limited matrix as set forth in the original Notice filed herein, and was sufficient and proper in the circumstances. The deadline to file an objection expired on March 3, 2003, which includes three days for service by mail. No objections to the Motion were filed.

3. The Settlement should be approved.

4. Morey's Seafood International, LLC has paid the sum of

\$51,300 to the Chapter 7 Trustee. Upon entry of this Order, the parties will submit a Stipulated Order dismissing the Adversary Proceeding with prejudice.

IT IS THEREFORE ORDERED that the Chapter 7 Trustee's Amended Motion to Approve Settlement of Adversary Proceeding 02-1106-S is granted, and the settlement of Adversary Proceeding 02-1106-S is approved as set forth in the Motion.
