**SECOND INTERIM APPLICATION BY ATTORNEYS FOR
CHAPTER 7 TRUSTEE THE FOR ALLOWANCE AND PAYMENT OF
COMPENSATION FOR THE PERIOD OF MAY 1, 2003 TO DECEMBER 31, 2003**

The law firm of Davis & Pierce., P.C. ("Attorneys"), Counsel for the Chapter 7 Trustee, submits this application for allowance and payment of compensation pursuant to Bankruptcy Code §§330 and 503.

1. Second Application Period; Amount of Compensation Sought. In this Second Application, Attorneys seek allowance and payment of compensation for services rendered and costs incurred between May 1, 2003 through December 31, 2003 (the "Second Application Period"), as itemized on the attached exhibits. The requested attorney's fees, costs and taxes for the Second Application Period are summarized as follows:

a.	Attorney and Paralegal Fees:	\$502,701.50.
b.	Expenses:	\$ 24,724.89.
c.	Tax:	<u>\$ 29,219.66.</u>
	Total:	\$556,646.05

Less payments received: (\$421,085.07)

Total Amount Due: \$135,560.98

2. Recoveries to date: As of the date of the filing of this Second Application, Attorneys have resolved 60 adversary proceedings out of 102 filed, and have recovered **\$3,561,537.51** for the estate. In addition, another **\$802,848.71** in settlements have been agreed to but not yet paid, due to the waiting period for objections, completion of payment plans and other factors.

3. General Description of Services Rendered on Behalf of the Chapter 7 Trustee. As more fully set out in the Billing Recap, in general, Attorneys' services rendered for the Chapter 7 Trustee during the Second Application Period have included, among other things:

- A. Pre-Petition Preferential Transfer and Fraudulent Transfer Claims: Trial, litigation and settlement negotiations with regard to 129 claims (including 96 adversary proceedings);
- B. Post-Petition Pre-Paid and Account Receivable Claims: Litigation and settlement negotiations with regard to 27 claims (including 6 adversary proceedings);
- C. Assisting in the sale of certain liquor license, and
- D. Preparation of Fee Applications and other administrative services.

4. Time Charged for Multiple Attorneys and Allocation of Responsibility. During the Second Application Period, Attorneys worked a total of 3015.65 hours of attorney time and 304.6 hours of legal assistant time for professional services rendered on behalf of the Chapter 7 Trustee. As shown on the "Summary of Hours Billed by Matter and Timekeeper," Exhibit A, Page 0 0016, Attorneys "no charged" a total of \$11,262.00 in the Second Application Period. In billing and charging for services provided by multiple attorneys and allocating responsibility, the Attorneys attempted to minimize duplication of effort and overlap of responsibilities.

5. First Application Period: Amount of Compensation Awarded and Paid. On August 18, 2003, the Court entered its "Amended Order Approving First Interim Application By Attorneys for the Trustee for Allowance and Payment of Compensation for the Period February 2002 To April 30, 2003," in which Attorneys were awarded \$354,541.61 for attorney's fees, services, expenses and taxes. This amount has been paid, and no balance remains due and owing.

6. Commencement of the Bankruptcy Case. On February 8, 2001, the Debtor filed a

voluntary petition for relief under Chapter 11 of the Bankruptcy Code. An order for relief on the petition was entered the same date as a matter of course. On December 19, 2001, the Debtor converted the case to a Chapter 7 case, and the Trustee was appointed.

7. Trustee's Employment of Davis & Pierce, P.C. ("Attorneys"). On December 21, 2002, the Trustee filed its Motion to Employ Davis & Pierce, P.C. as her counsel. On July 3, 2002, the Court entered the Order Granting Trustee's Motion to Employ Davis & Pierce, P.C. as Counsel for the Trustee (the "D&P Employment Order"), approving the Trustee's employment of Attorneys effective as of the Conversion Date. The Trustee was authorized to pay Attorneys up to and including 75% of fees, and up to and including 100% of reimbursable costs and applicable gross receipts tax, subject to ultimate approval of the paid compensation.

8. Services Rendered Were Actual and Necessary; Fees Charged are Reasonable. Following its employment by the Chapter 7 Trustee, Attorneys have represented the Trustee since her appointment. The services rendered and the costs and expenses incurred by Attorneys on behalf of the Chapter 7 Trustee during the Second Application Period, for which compensation is sought, were actual and necessary. The amount charged for fees is reasonable based on the nature, extent and value of the services and the amount of time spent providing the services.

9. Itemization of Fees and Costs and Description of Services Rendered. The services provided by Attorneys in the Second Application Period are set forth in detail on the billing recap attached hereto as Exhibit "A", which is incorporated herein by reference (the "Billing Recap"). Copies of the original billing statements will be available for inspection by any interested party in the Office of the Bankruptcy Court Clerk, 500 Gold Av. SW, 10th Floor,

Albuquerque, NM 87102, or on the Court's ACE filing system. Copies of expense receipts are available for reproduction upon request. The billing statements itemize all charges for professional services, reimbursable costs and expenses and gross receipts tax; set out the hourly rates for each attorney and legal assistant employed by Attorneys who rendered services to the Chapter 7 Trustee; separately describe the services rendered and hours worked by each individual each day for each specific task performed during the Second Application Period, and itemize all expense charges. Page 0 0016 of the Billing Recap, Exhibit A hereto, contains a Summary of the total hours and total charges per individual. The accounting of services, costs and expenses as set out in the billing statements and Billing Recap is true and correct to the best of Attorneys' knowledge, information and belief.

10. Billing Rates, Time Billed and Rates for Other Charges. During the Second Application Period, the billing rates charged for attorneys and legal assistants were charged at Attorneys' normal and customary billing rates, or less, charged to clients other than the Trustee, as shown on the attached "Attorney and Timekeeper Rates and Time Allocation," (see Page 0 0016 of the Billing Recap, Exhibit A hereto.)

Attorneys, in accordance with Attorneys' customary billing practices, also charged for costs and expenses, including \$0.25 per page for in-house photocopying, \$0.25 per mile for hand deliveries, \$1.00 per page for telecopies (outgoing only), and actual out-of-pocket expenses for other expenses such as travel and meals while traveling, hotels, taxis, tips, deposition transcripts, computer aided legal research, postage, long distance telephone and overnight mail.

11. Other Factors. Attorneys also support this Second Fee Application with discussion of various other factors, as follows:

(a) Expertise and experience in the area of bankruptcy of the Attorneys rendering services to the Chapter 7 Trustee. The Attorneys have extensive expertise and experience in Chapter 11 bankruptcies, and enjoy a respected reputation in the legal community for their work in both bankruptcy matters and in general commercial litigation. Mr. Davis has a Certificate of Specialization from the New Mexico Board of Legal Specialization in Bankruptcy (Business) Law and a Masters in Business Administration. Mr. Pierce has a Certificate of Specialization from the New Mexico Board of Legal Specialization in Bankruptcy (Consumer) Law.

(b) Method used to compute time charges. Applicant billed hourly for its services for representation of client at normal, set, hourly rates for each attorney and timekeeper in the firm. The number of hours and hourly rates for each timekeeper who worked on representation of the client in this proceeding are itemized in this application. The billing invoices reflect contemporaneous time entries which set forth the services performed, the dates on which such services were performed, the identity of the individual performing the work, and the time spent in tenth of one hour increments.

(c) Relative billing rates of Attorneys for in-court and out-of-court hours. The Attorneys bill the same rates for in-court and out-of-court hours. Travel time is billed at the normal hourly rate times $\frac{1}{2}$; Attorneys use travel time for review of pleadings, files and preparation for hearings or meetings. Layover time between flights is not billed unless specific legal work is being performed during the layover.

(d) Difficulty of case dealt with by Attorneys. This case is large, complex and difficult. Representation of the Trustee has made substantial demands upon the time and skills of

Attorneys. Attorneys have turned away other work, and narrowed its client base, to have adequate time to represent the Trustee.

(e) Results Achieved and Benefit of the Results to the Estate. See paragraph 2, above.

12. Services Rendered Solely for the Chapter 7 Trustee; No Fee Sharing Arrangement.

All professional services for which allowance and payment of compensation is requested were performed by Attorneys for the Chapter 7 Trustee and not on behalf of the debtor or any other committee or person. Attorneys have not shared or agreed to share any compensation received or to be received by it for services rendered in or in connection with this case with any person except with employees of Attorneys in the ordinary course of business.


WHEREFORE, Attorneys respectfully request that the Court allow, as a priority, administrative expense, the following:


