**DISCLOSURE OF CORLETT, PROBST & BOYD, L.L.P. (SURVEYOR)**  
**PURSUANT TO BANKRUPTCY RULES 2014 AND 2016**

Corlett, Probst & Boyd, L.L.P. ("Surveyor") hereby states, in connection with the motion of Yvette J. Gonzales, the Chapter 7 trustee of the estate of Furr's Supermarkets, Inc. (the "Trustee"), to employ Surveyor to survey the boundaries and natural drainage of a certain parcel of real property in Wichita Falls, Texas (the "Property"):

1. The undersigned is an officer of Surveyor.
2. To the best of the undersigned's knowledge, information, and belief, after making reasonable inquiry, Surveyor has no connection with the Trustee, the estate of Furr's Supermarkets, Inc. (the "Debtor"), Debtor's creditors, or any other party in interest in this case, or their respective attorneys and accountants, the United States Trustee, or any person employed in the office of the United States Trustee, except that Surveyor may render professional services to clients who are or may be adverse to the Debtor's bankruptcy estate, which services are wholly unrelated to the estate or to this bankruptcy case.
3. If the Court approves the Trustee's employment of Surveyor, the fee for the services to be performed is a flat fee of \$1,500 plus sales tax of \$123.25 to be paid upon or within six months of completion of the survey.

4. The fees Surveyor charges are ordinary and reasonable in the region where the Property is located.

5. Surveyor has been in the business of land surveys since the 1930's. The principals of the Surveyor have extensive experience in conducting land surveys. Mr. Boyd has 30 years of experience, and both Mr. Boyd and Mr. Probst are professional engineers and registered licensed land surveyors. In addition, Mr. Hinton is a professional engineer.

6. Surveyor has received no transfer, assignment or pledge of property for post-petition services.

7. Surveyor has not shared or agreed to share with any other person or entity, other than with members or regular associates or employees of Surveyor, any compensation paid or to be paid by Debtor in or in connection with this bankruptcy case.
