3. Kimberly A. Middlebrooks accepts designation as resident counsel for Mr. Marchiondo.


4. Mr. Marchiondo read and is familiar with the Local Rules of this Court.

2. I graduated from Pepperdine University Law School in 1987


3. I was admitted to practice law in the State of California in 1987. I have remained an attorney in good standing in the State of California

4. I have never been the subject of disciplinary action by any bar or court






