
CORRECTION TO MOTION FOR ORDER EXTENDING TIME
TO ASSUME OR REJECT UNEXPIRED LEASE WITH
TRI-STATE COMMERCIAL ASSOCIATES

Furr's Supermarkets, Inc. hereby corrects a typographical error in its Motion For Order Extending Time to Assume or Reject Unexpired Lease With Tri-State Commercial Associates (the "Motion"), filed May 11, 2001.

Paragraph 6 of the Motion is revised to add the word "not" after the phrase "importantly, since the April 3, 2001 hearing, Tri-State has", so that paragraph 6 reads as follows:

6. Importantly, since the April 3, 2001 hearing, Tri-State has not chosen to seek a determination as to the effectiveness of the Debtor's post-petition exercise of the renewal option. Tri-State can raise the issue if the Debtor moves to assume and assign the lease. If the Debtor elects to reject the lease, the issue will be moot.
