

DISTRIBUTING COMPANY, INC. TO MARCH 14, 2001 FINAL ORDER (1)
AUTHORIZING DEBTOR TO OBTAIN SECURED FINANCING, (2) GRANTING
ADEQUATE PROTECTION AND (3) GRANTING OTHER RELIEF**

Creditors New Mexico Beverage Company, Inc., Southern Wine & Spirits of New Mexico, Inc., and National Distributing Company, Inc., by counsel of record, Hisey & Cadigan (Michael J. 
