**UNITED STATES TRUSTEE'S' LIMITED OBJECTION TO
APPLICATION FOR EMPLOYMENT OF
WALTER PARKER, CAI, AARE, AUCTIONEERS**

The United States Trustee for the District of New Mexico hereby objects to the application for employment of Walter Parker, CAI, AARE, auctioneers (Application), and as her reasons therefore states the following:

1. The bond provided by Walter Parker, CAI, AARE. Auctioneers (Walter Parker) provides that the surety may terminate the bond upon thirty days written notice to the U.S Trustee, but does not make clear that any liability accrued prior to termination would survive. Any approval of the Walter Parker's employment should be contingent upon express language in the bond substantially as follows:


Surety shall not be discharged from any liability accrued under this bond prior to the effective date of a notice of termination.

2. While the standard commission for auction sales in this District is ten percent, the U.S Trustee will not object to the 20 percent commission requested in the Application based solely on the circumstances of this case, in which the property being auctioned is fully encumbered.
