**DEBTOR'S MOTION TO SHORTEN DEADLINE TO EIGHT DAYS FOR
OBJECTIONS TO MOTION TO REJECT TWO UNEXPIRED REAL ESTATE LEASES**

Debtor in Furr's Supermarkets, Inc., ("Debtor"), moves the Court for an order shortening the deadline for objections to its Motion To Reject Two Unexpired Real Estate Leases to eight days, and in support states as follows:

1. On February 8, 2001 (the "Petition Date"), the Debtor filed a voluntary petition in this Court under chapter 11 of title 11 of the United States Bankruptcy Code. The Debtor continues to operate its business and manage its properties as debtor-in-possession under Bankruptcy Code §§ 1107(a) and 1108.


2. On May 17, 2001, the Debtor filed its Motion To Reject Two Unexpired Real Estate Leases ("Motion").

3. Good cause exists to shorten the objection deadline to eight days. The leases sought to be rejected cost the estate approximately \$66,500 per month. The matters raised in the Motion are routine, and any objection would be easy to prepare. The estate would benefit by an early rejection of the leases at issue.

WHEREFORE, Debtor moves the Court for an order shortening the deadline for objections to the Motion to eight days plus three days for mailing, and for such other and further relief as the Court deems proper.


