**DEBTOR'S MOTION TO SHORTEN DEADLINE TO EIGHT DAYS FOR
OBJECTIONS TO MOTION TO REJECT GE CAPITAL EQUIPMENT LEASE
FOR STORE #898**

Debtor in Furr's Supermarkets, Inc., ("Debtor"), moves the Court for an order shortening the deadline for objections to its Motion To Reject GE Capital Equipment Lease For Store #898 to eight days, and in support states as follows:

1. On February 8, 2001 (the "Petition Date"), the Debtor filed a voluntary petition in this Court under chapter 11 of title 11 of the United States Bankruptcy Code. The Debtor continues to operate its business and manage its properties as debtor-in-possession under Bankruptcy Code §§ 1107(a) and 1108.


2. On August 13, 2001, the Debtor filed its Motion To Reject GE Capital Equipment Lease For Store #898 (the "Motion").

3. Good cause exists to shorten the objection deadline to eight days. The lease sought to be rejected cost the estate approximately \$21,356 per month. The matters raised in the Motion are routine, and any objection would be easy to prepare. The estate would benefit by an early rejection of the lease at issue.

WHEREFORE, Debtor moves the Court for an order shortening the deadline for objections to the Motion be to eight days plus three days for mailing, and for such other and further relief as the Court deems proper.


