

If objections are timely filed, a hearing will be held on short notice to objectors only before the Honorable James S. Starzynski at the Federal Building and United States Courthouse, 421 Gold Avenue S.W., Albuquerque, New Mexico.

If no objections are timely filed, the Court may consider entry of an order granting the motion.


