NOTICE OF DEADLINE TO OBJECT TO MOTION


On October 9, 2001, Sun Valley Fruit Company, Inc., filed a Motion to Compel immediate Payment of Post-Petition Paca Trust Claims in which it asks the Court to compel the debtor to immediately pay the accrued post-petition claim of Sun Valley under the Perishable Agricultural Commodities Act, 7 USC § 499e(c) (PACA). The motion is on file with the clerk, available for inspection by interested parties.

Box 546, Albuquerque, New Mexico 87103-0546, **WITHIN 20 DAYS OF THE DATE OF MAILING OF THIS NOTICE** and you must provide a copy of your objection to John E. Farrow, Esq., Fairfield, Farrow, Flowers, Pierson & Strotz, P.C., P.O. Box 35400, Albuquerque, New Mexico 87176.

If objections are timely filed, a hearing will be held on short notice to objectors only before the Honorable James S. Starzynski at the Federal Building and United States Courthouse, 421 Gold Avenue S.W., Albuquerque, New Mexico.

If no objections are timely filed, the Court may consider entry of an order granting the motion.


