Starzynski, United States Bankruptcy Judge in the United States Courthouse, 421 Gold Avenue S.W., Albuquerque, New Mexico on short notice to the movant and any objecting parties. If no objections are timely filed, the Court may consider entry of an Order granting the relief requested in the Motion without further notice.


