**NOTICE OF DEADLINE TO OBJECT TO
MOTION OF UNITED FOOD AND COMMERCIAL WORKERS UNION
LOCAL 540 FOR ORDER ALLOWING AND REQUIRING IMMEDIATE
PAYMENT OF ADMINISTRATIVE EXPENSES**

On October 25, 2001, United Food and Commercial Workers Union Local 540 ("Local 540") filed a Motion For Order Allowing and Requiring Immediate Payment of Administrative Expenses. The Motion seeks payment of the unpaid employee claims for medical benefits provided under Furr's Supermarkets, Inc. Group Health Plan ("Group Health Plan"). Pursuant to the unrejected Collective Bargaining Agreement between Local 540 and the Debtor, Local 540 members are participants in the Group Health Plan, which pays for various health and medical expenses incurred by Local 540 members. Local 540 members participated in the Group Health Plan, rather than in a separate Taft-Hartley trust fund established under the Collective Bargaining Agreement. The Motion is on file with the Clerk and is available for inspection by interested parties.

If you object to the Motion, you must file the original and one copy of your written objection with the Clerk of the United States Bankruptcy Court, District of New Mexico, 421 Gold Avenue, S.W., Third Floor, Post Office Box 546, Albuquerque, New Mexico 87103-0546, **WITHIN TWENTY (20) DAYS OF THE DATE OF MAILING OF THIS NOTICE** and you must provide a copy of your objection to Michael D. 
