
2. Preliminary Hearing on Fee Applications Filed by November 6, 2001. At 1:30 p.m. MDT on December 6, 2001, the Court will hold a preliminary hearing on objections to any professional fee applications filed and noticed on or before November 6, 2001 (including any applications already filed and noticed, but not including any applications for which preliminary hearings have already been held). The hearing will be held on the Second Floor, Federal Building and United States Courthouse, 421 Gold Avenue SW, Albuquerque, New Mexico. Out of town counsel may appear by telephone if a written request to do so is faxed to the Court at (505) 348-2432 at least 24 hours before the hearing.

3. Final Hearing on Fee Applications Filed by November 6, 2001. Beginning at 9:00 a.m. MDT on January 29, 2001, and continuing on January 30, 2001 and January 31, 2001, the Court will hold a final hearing on any objections to any professional fee applications filed and noticed on or before November 6, 2001 (including any applications already filed and noticed). The hearing will be held on the Second Floor, Federal Building and United States Courthouse, 421 Gold Avenue SW, Albuquerque, New Mexico.


