**NOTICE OF DEADLINE FOR OBJECTING TO FIRST INTERIM FEE APPLICATION OF
SAGE ACCOUNTING, SMALL/KEFAUVER CPA'S, P.C., ACCOUNTANTS FOR THE
DEBTOR IN POSSESSION**

On November 6, 2001, Sage Accounting, Small/Kefauver CPA's, P.C., accountants for the debtor Furr's Supermarkets, Inc., filed its First Interim Application for Allowance and Payment of Fees and Expenses (the "Fee Application"). A copy of the Fee Application can be inspected at the office of the Clerk of the Bankruptcy Court, Federal Building and United States Courthouse, 421 Gold Avenue, SW, Third Floor, Albuquerque, New Mexico 87102, or may be obtained from the undersigned counsel.

In the Fee Application, Sage requests fees for professional services and reimbursement of costs and tax for the period from September 21, 2001, through November 2, 2001, in the amount of \$31,750.00 for fees, \$2,390.41 for expenses, and \$1,984.41 for New Mexico gross receipts tax, for a total of \$36,124.82. Of this amount, \$27,725.43 has been paid, leaving a balance owing of \$8,399.39. The Fee Application requests Court approval of these amounts, that Furr's be authorized to pay the remaining balance, and that Furr's secured lenders be authorized and directed to pay such amount. The Fee Application, which is on file with the Bankruptcy Court, includes an itemization of the services rendered and costs incurred.

If you object to the Fee Application, you must file the original and one copy of your written objection with the Clerk of the United States Bankruptcy Court, 421 Gold Avenue, SW, Third Floor, Post Office Box 546, Albuquerque, New Mexico 87103-0546, on or before twenty days from the date of mailing of this notice, plus three days for mailing, for a total of twenty-three days, **i.e., on or before November 29, 2001**, and must serve a copy of the objection on Rachel L. Kefauver, Sage Accounting, Small/Kefauver CPA's, P.C. at the address given below. If any objections are timely filed, a preliminary hearing will be held before the Honorable James S. Starzynski, United States Bankruptcy Judge, on **December 6, 2001 at 1:30 p.m. MDT** at the United States Bankruptcy Court, 421 Gold Avenue, SW, Second Floor, Albuquerque, New Mexico. If no objections are timely filed, an order approving the Fee Application will be presented to the Court for entry without a hearing or further notice.
