**NOTICE OF DEADLINE FOR FILING OBJECTIONS TO MOTION TO LIFT STAY**

Wilger Enterprises, Inc. [hereinafter, "Wilger"] has filed papers with the Court, requesting that the Court enter an order lifting the stay against Debtors and allowing Movants to assert that a partnership was created by and between Debtor and Broadway Vista Partners related to the development of the property at 8100 Ventura in Albuquerque, New Mexico in *Wilger Enterprises, Inc. v. Broadway Vista Partners, et al.* Second Judicial District Court Cause No. CV-2001-03366. Movant does not seek to add Debtor to the State Court suit or assert a damage claim against Debtor.

**You should read these papers carefully and discuss them with your attorney, if you have one in this bankruptcy case. (If you do not have an attorney, you may wish to consult one.) Your rights may be affected.**

If you do not want the court to lift the stay to allow Movants to assert a Crossclaim against Debtors, or if you want the Court to consider your views on the motion, then, within 20 days of the mailing of this notice, you or your attorney must:

File the original and one copy of your written objection with the clerk of the Court (Michael M. Shepperd, Clerk, United States Bankruptcy Court, District of New Mexico, 421 Gold Avenue S.W., Fifth Floor, P.O. Box 546, Albuquerque, New Mexico 87103-0546)

If you mail your objection to the Court for filing, you must mail it early enough so the Court will receive it on or before the date stated above. You must provide a copy of your objection to counsel for the Movant Julie J. Vargas, Hunt & Davis, P.C., P.O. Box 30088, Albuquerque, NM 87190-0088.

If objections are timely filed, a hearing will be held on short notice before the Honorable James S. Starzynski at the Federal Building and United States Courthouse, 421 Gold Avenue S.W., Albuquerque, New Mexico.

If you or your attorney do not take these steps, the Court may decide that you do not oppose the relief sought in the motion and may enter an order granting that relief.
