

COMPENSATION AND REIMBURSEMENT OF EXPENSES TO  
DELOITTE CONSULTING L.P. AND DELOITTE & TOUCHE LLP,  
AS FINANCIAL ADVISORS AND REORGANIZATION CONSULTANTS  
TO THE OFFICIAL UNSECURED CREDITORS COMMITTEE  
FOR THE PERIOD FEBRUARY 21 THROUGH AUGUST 31, 2001**

Metropolitan Life Insurance Company, in any and all capacities wherein Heller Financial, Inc. does not expressly act as its agent ("MetLife"), by and through its undersigned attorneys, Bingham Dana LLP, and J.D. Behles & Associates, a Commercial Law Firm, P.C., hereby submits its Objection To First Interim Application For Allowance Of Compensation And Reimbursement Of Expenses To Deloitte Consulting L.P. And Deloitte & Touche LLP. As Financial Advisors And Reorganization Consultants To The Official Unsecured Creditors Committee For The Period February 21 Through August 31, 2001, and states as follows:

1. Heller Financial, Inc., as agent for itself, Bank of America, N.A., Fleet Capital Corporation and MetLife has previously filed its Objection to First Interim Fee Application for Allowance of Compensation and Reimbursement of Expenses to Deloitte Consulting, L.P., and Deloitte & Touche, LLP (the "Heller Objection").

MetLife hereby adopts the arguments and objections set forth in the Heller Objection as if fully set forth herein to the first interim application of Deloitte Consulting L.P. and Deloitte & Touche LLP for allowance and payment of fees and reimbursement of expenses, and reserves it right to submit additional and more detailed objections prior to or at any hearing to be held on this matter, including, without limitation, arguments relating to the priority of professionals' fees and expense reimbursement and limitations thereon embodied in the "carve-out" provisions of the Debtor's financing orders.




