**LIMITED OBJECTION OF OFFICIAL COMMITTEE
OF UNSECURED CREDITORS OF FURR'S SUPERMARKETS, INC.
TO APPLICATION FOR ORDER AUTHORIZING EMPLOYMENT AND
RETENTION OF PROFESSIONALS USED IN ORDINARY COURSE OF BUSINESS**

The Official Committee of Unsecured Creditors of Furr's Supermarkets, Inc. (the "UCC") by and through its counsel Pepper Hamilton, LLP (Stuart Hertzberg, Esq. and I. William Cohen, Esq.), and local counsel Davis & Pierce, P.C. (William F. Davis, Esq.), for its Objection, hereby STATES:

1. On February 8, 2001, Debtor filed a voluntary petition for relief under Chapter 11 of the Bankruptcy Code.
2. The Application for Order Authorizing Employment and Retention of Professionals Used in Ordinary Course of Business ("Application") was filed on March 1, 2001. The deadline to object to the Application expires on March 26, 2001.
3. The UCC objects to the retention of attorneys to be used for defense of the Debtor in personal injury litigation. All litigation of personal injury claims is presently stayed under § 362 of the Bankruptcy Code.
4. The UCC has proposed the use of an Alternative Dispute Resolution Procedure which would eliminate the need of personal injury attorneys to be retained and would be far less costly to the estate.

7. The UCC does not object to the retention of the remainder of professionals listed on Exhibit "A" to the Application.


WHEREFORE, the Committee objects to the Application for Order Authorizing


