TO EMERGENCY MOTION OF PINNACLE LOGISTICS, INC.

EXPEDITED FINAL HEARING ON MAY 18, 2001 MOTION FOR
RELIEF FROM AUTOMATIC STAY**

Davis, Esq.), for its Objection to the Emergency Motion of Pinnacle Logistics, Inc. and Countrywide Logistics, Inc. For Emergency and Expedited Final Hearing on May 18, 2001 Motion for Relief from Automatic Stay, STATES:


