**ORDER REGARDING PAYMENT OF LIQUOR
WHOLESALEERS AND TRANSFERS OF LIQUOR LICENSES**

This matter came before the Court by the agreement of the parties hereto, the Debtor, Desert Eagle Distributing Company, The New Mexico Beverage Company, Southern Wine & Spirits, National Distributing Company, Premier Distributing Co., Joe G. Maloof & Co., (collectively, "Wholesalers") Heller Financial, Inc. ("Heller"), as agent for Fleet Capital Corporation, Bank of America N.A., Heller and Metropolitan Life Insurance Company ("Met Life"); and Met Life, and MetLife (collectively, "Lenders") and the Unsecured Creditors Committee ("UCC").

THE COURT FINDS:

1. As used in this Order:

"AGD" means the New Mexico Alcohol and Gaming Division.

"Clearance Letter" means a letter from a wholesaler, or its counsel, in a form substantially similar to the attached Exhibit A addressed to AGD, stating that the Debtor has made satisfactory arrangements with the Wholesaler to pay the amounts owed by the Debtor to the Wholesaler for sales relating to the Licenses.

"Lenders" means Heller and MetLife.

"Licenses" means the following New Mexico Liquor Licenses:

“Wholesalers” means Desert Eagle Distributing Company, The New Mexico Beverage Company, Southern Wine & Spirits, National Distributing Company, and Premier Distributing Co.

“Wholesaler Clearance” means a wholesaler clearancc, in the form specified by AGD, relating to the Licenses.

“August 28 Order” means the Court’s order regarding transfer of the Licenses entered on the date.

2. Lenders, the Debtor and the Unsecured Creditor’s Committec have agreed to and support the relief granted in this Order, as have the Wholsalers.

3. This order is necessary to facilitate and enable the Closing of the Fleming sale, which would not be possible without the Wholsalers delivering their Debt Clearances prior to receipt of payment in full, because the Debtor is unable to pay the Wholesaler’s

debts without receipt of the funds to be received in the Closing, and the Closing cannot proceed unless and until the leases of the liquor licenses are approved by AGD.

4. Counsel for the Debtor, and counsel for Lenders have advised counsel for the Wholesalers that they contend that payments hereunder are being made under compulsion and under protest. All parties contend that they have not waived and specifically reserve any rights, claims or defenses which may exist in connection with this matter. Without limitation, the Debtor, Met Life and Heller contend that they have not waived rights to appeal the August 28 Order, or to seek disgorgement in a separate proceeding or to contest the amount and/or priority or any other aspect of the Wholesalers' claims, and Wholesalers contend that they have not waived the right to contend that by accepting the benefits of the transfers of the Licenses, Met Life, Heller and the Debtor have in fact waived such rights, are estopped by doctrines such as res judicata, or have rendered their claims moot. The parties agree that this Order will not be construed to affect any of the parties' contentions in this regard.

3. No other party in interest or creditor needs notice of this Order, and entry of this order is proper and appropriate under the circumstances. The Court has jurisdiction to enter this Order and will retain jurisdiction to enforce its terms, even if the Court's order entered August 28, 2001 regarding the transfer of the Licenses is appealed.

4. The Wholesalers have prepared and will deliver to counsel for the Debtor executed Debt Clearances or a Clearance letter on the Licenses. Such deliveries shall be accomplished by 11:30 a.m. Friday August 31, 2001, and are being given in reliance on the relief granted in this Order.

THE COURT ORDERS:

1. The Debt Clearances or Clearance Letters on the Licenses are subject to and protected by the terms of this Order. This Order shall not be construed to affect any of the parties' contentions as set forth in the Recitals above, and all such rights, claims and defenses are reserved.

2. The Debtor is authorized and directed to pay the Wholesalers, from the proceeds of the sale authorized by the Order entered July 3, 2001 (the "Transaction"), the amounts set forth on Exhibit "B" hereto, which payments shall be made by close of business on August 31, 2001 (if feasible) but in any event no later than 2:00 p.m. September 4, 2001, by cash, certified funds or completed wire transfer of good funds. The Lenders shall cooperate fully and completely with the Debtor in every respect to facilitate and complete payment to the Wholesalers of the amounts shown on Exhibit B from the proceeds of the Transaction at the time the Transaction funds.

3. The Lenders shall take no action whatever to impede or prevent such payments to the Wholesalers. The Lenders have expressly covenanted and agreed that they will not take any action, or by inaction or otherwise ^{wise} attempt in any way to delay, enjoin, stay, modify or prevent payment to the Wholesalers of the amounts shown on Exhibit B, and they are so ordered herein.

4. If the Transaction does not close on August 31, 2001, the original leases of Licenses made by the Debtor in connection with the Transaction shall be void, and shall not be delivered to Fleming or any purchaser from Fleming, but shall be destroyed, and counsel for the Debtor shall file a certificate with this Court, and with AGD stating that the leases were void and have been destroyed. Further, by 5:00 p.m. on September 4, 2001,

unless the Wholesalers have received the payments in the manner specified above, the Debtor and its counsel shall return all Liquor Clearances and Clearance Letters given by the Wholesalers, including any copies delivered to AGD or transmitted by facsimile to AGD, and all copies and originals shall be delivered to counsel for Wholesalers.

7. Any appeal of the August 28 Order will not divest the Court of jurisdiction or of authority to enforce this Order, and Lenders, UCC and Debtor expressly agree that in the event of an appeal of the August 28 Order, no application for a stay pending appeal will affect Wholesalers rights to receive payment under this Order.

7. This letter is without prejudice to Debtor's right to make other satisfactory arrangements with liquor wholesalers other than the Wholesalers.






