IT IS FURTHER ORDERED that the United States Trustee is hereby authorized to give notice of her motion to convert by publication to all other creditors and parties in interest,



If objections are timely filed, a hearing to consider them will be held on short notice to objecting parties before the Honorable James S. Starzynski, United States Bankruptcy Court, 421 Gold Avenue S.W., 2nd Floor, Albuquerque, N.M. 87103-056

If no objections are timely filed, the Court may consider entry of an order granting the motion.
