
**ORDER REGARDING APPOINTMENT OF ROBERT L.  
BERGER AND ASSOCIATES, LLC AS CLAIMS, NOTICING  
AND BALLOTING AGENT OF THE  
BANKRUPTCY COURT UNDER TO 28 U.S.C. §156(C)**

This matter came before the Court on December 6, 2001. Present in person or by telephone were counsel for each the Debtor, Unsecured Creditors Committee, Metropolitan Life Insurance Company and the United States Trustee. Also present by telephone was Robert L. Berger. On February 20, 2001, the Court entered its Order Appointing Robert L. Berger and Associates, LLC as Claims, Noticing and Balloting Agent of the Bankruptcy Court Under 28 U.S.C. §156(c) (Docket No. 96) (the "Claims, Noticing and Balloting Agent Order"). The Court, having determined that the relief granted by this order is appropriate, and all parties appearing having concurred therein, it is

ORDERED that Robert L. Berger and Associates, LLC ("Berger") hereby is relieved of its responsibility as

claims, noticing and balloting agent of the Bankruptcy Court in connection with this case under 28 U.S.C. §156(c), effective upon entry of this order. Without limiting the foregoing, Berger no longer shall be required to file proofs of claim or interest in this case or maintain a register in connection therewith, or provide copies of such claims to the public, or provide any of the other services it was appointed to perform under the Claims, Noticing and Balloting Agent Order.

Within ten (10) days after entry of this Order, Berger is directed to remit to the Clerk's Office for this Court all originals of all proofs of claim and proofs of interest in this case that were transmitted to Berger, with a copy of the claims register prepared by Berger.
