

**ORDER DIRECTING PAYMENT OF SUCCESS FEE TO
GEORGE GOLLEHER AND GREGORY MAYS**

This matter having come before the Court for final hearing on January 16, 2002, at 9:00 a.m.; all required Notice having been provided, and upon all the proceedings before the Court and after due deliberation, the Court having issued oral Findings of Fact and Conclusions of Law as authorized by Rule 7052 of the Bankruptcy Rules, it is hereby

ORDERED that George Golleher and Gregory Mays earned a success bonus in the combined amount of one million five hundred thousand dollars (\$1,500,000.00) as a result of the Debtor's sale of assets to the Fleming Companies, Inc. approved by an order entered July 3, 2001, and such success bonus is a cost of sale prior to the liens of the lenders, not subject to disgorgement, setoff, claims, demands and causes of action.

IT IS FURTHER ORDERED that, seven hundred and fifty thousand dollars (\$750,000.00) of this amount having already been paid, the Chapter 7 Trustee is directed to pay the remaining seven hundred fifty thousand dollars (\$750,000.00) from the reserve established pursuant to the first post closing financing order entered September 26, 2001 (Docket No. 1101) for payment of a success fee to George Golleher and Gregory Mays.
