**ORDER GRANTING APPLICATION FOR ALLOWANCE AND PAYMENT
OF FEES AND EXPENSES OF CHANIN CAPITAL PARTNERS, LLC**

THIS MATTER came before the Court on the Application for Allowance and Payment of Fees and Expenses of Chanin Capital Partners, LLC. The Court, being fully advised, hereby FINDS:

1. The Debtor filed its petition under Chapter 11 of Title 11 of the United States Code on February 8, 2001.

2. On October 3, 2001 the attorneys for the Unsecured Creditors' Committee filed its application for allowance and payment of fees and expenses of Chanin Capital Partners, LLC.

3. Notice of the Application was mailed on October 3, 2001 to the creditors of the Debtors, as set forth on the official mailing matrix attached to the original Notice filed herein. The Notice was proper in form and content.

4. Pursuant to the Notice of the Application filed herein, October 26, 2001 was the deadline to respond to the Application, including three days for mailing.

5. Chanin Capital Partners, LLC has voluntarily reduced its expense application to resolve objections to their Application by \$5,000.00.

6. The Office of the United States Trustee filed an objection on October 18, 2001, which objection has been resolved as indicated by the approval of the form of this Order.

7. The Debtor filed an objection on October 26, 2001, which objection has been resolved as indicated by the approval of the form of this Order.

8. No other Objections have been filed, timely or otherwise.

9. The requested fees, costs and taxes as stated above are reasonable and necessary, and the Application is well taken and should be granted as set out below.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Application is granted after reduction of \$5,000.00 of expenses, pursuant to 11 U.S.C. §§330 and 503, in the sum of \$323,977.26, and is allowed as compensation to Chanin Capital Partners, LLC in full, as an administrative expense.
