

**SCHEDULING ORDER REGARDING CONTINUED FINAL
HEARING ON FEE APPLICATIONS BY
DELOITTE CONSULTING, L. P., DELOITTE & TOUCHE LLP
AND PEPPER HAMILTON, LLP**


On February 4, 2002, the Court held a Scheduling Conference regarding the continuation of the final hearing on fee applications filed by Deloitte Consulting L.P., Deloitte & Touche LLP, and Pepper Hamilton, LLP and the Application for Reimbursement filed by the Official Unsecured Creditors Committee. The Court determined that the hearing on the fee applications will proceed as follows:

1. The continuation of the hearing will begin at 9:00 a.m. on February 21, 2002. If needed, the hearing will continue through Friday, February 22, 2002.
2. I. William Cohen may file an Affidavit regarding time entries made by P. Coston on or before February 14, 2002. Such Affidavit shall be accompanied by P. Coston's timesheets for all dates on which he recorded time for which Pepper Hamilton is seeking payment in this bankruptcy case. Time entries for matters other than work performed for the Official Unsecured Creditors Committee in this case may be redacted. The time recorded for such other matters may not, however, be redacted. The Affidavit and timesheets must be delivered to all counsel below approving this Order so that they are received by all counsel listed below on or before or February 14, 2002.

3. I. William Cohen will appear at the hearing and shall be subject to continued cross-examination regarding the Pepper Hamilton fee applications.
