c. Keleher & McLeod, P.A. has represented the University of New Mexico generally for a number of years. When UNM learned of the filing of this case, it asked that Keleher & McLeod represent in this case.

d. Keleher & McLeod was approached by Friederich, Kindermann, GDI and International Computer Corporation to represent them in this case.


3. Keleher & McLeod, P.A. has written agreements with PNM and the NM Lottery, but the agreements are general in nature, and do not pertain specifically to this case.


