**STIPULATED ORDER MODIFYING THE AUTOMATIC STAY TO
ALLOW GREENLEAF COMPACTION INC. TO TAKE PROTECTIVE
CUSTODY OF ITS LEASED EQUIPMENT**


THIS MATTER having come before the Court upon stipulation of the parties; Furr's and Greenleaf, by and through their respective counsel as undersigned, have submitted this Stipulated Order to Lift the Automatic Stay to the limited extent necessary to allow Greenleaf to take protective custody of its leased equipment; the Court being fully advised enters the following:

IT IS HEREBY ORDERED that the automatic stay provided by §362 of the Bankruptcy Code is hereby modified to allow Greenleaf to take protective custody by removing its leased equipment from any Furr's store that has been closed or that will be closed. The stores which are closed on the date of the entry of this Order or which will be closed in the next week include the following:



Greenleaf shall retain custody of such equipment pending further Order of the Court. Greenleaf and/or Furr's shall provide a list of the closed stores and of the equipment that is repossessed by Greenleaf. This Order is entered without prejudice to the Debtor and Greenleaf as to the parties' respective rights and obligations pursuant to applicable bankruptcy law and the Master Equipment Lease. Greenleaf Compaction, Inc., may file a Notice as to the proposed disposition of any equipment repossessed by it, providing notice of deadline of twenty (20) days to object thereto. If no objections are filed, the automatic stay pursuant to 11 U.S.C. §362 shall be terminated upon conclusion of the notice period, without further notice. Further notice of this Order required by Bankruptcy Rule 4001(d) is waived.


