

investors, so the Germans decided to reorganize the company by splitting off the profitable grocery stores into a new company and bankrupting the company left behind with closed and unprofitable stores.

7. In the early 1990s, Furr's Supermarkets, Inc. was formed to be the new company. Furr's Supermarkets, Inc. was formed with approximately 70 stores and a warehouse.

8. In June of 1992, the company that was left behind, Furr's, Inc., changed its name to Rubus Realty Company. The German owners thought there would be less adverse publicity if Furr's, Inc. filed for bankruptcy under a new name.

9. The firm of William F. Davis & Assoc., P.C. represented Rubus Realty Company in the Bankruptcy filed on February 1, 1993, USBC No. 11-93-10329-RA. Rubus Realty Company was the successor in interest to Furr's, Inc. The firm of William F. Davis & Assoc., P.C. did not begin representing Rubus (Furr's, Inc.) until after Furr's Supermarkets, Inc. was formed.

10. During the representation of Rubus Realty Company the Law Firm of William F. Davis & Assoc., P.C. pursued various recoveries from Furr's Supermarkets, Inc. Among those were recoveries for preferential transfers, fraudulent conveyances, and contract actions.

11. All those issues were resolved to the satisfaction of Rubus Realty Company and Furr's Supermarkets, Inc. Rubus Realty Company's Plan of Reorganization was confirmed on August 31, 1994 and the Bankruptcy was closed on April 29, 1998. There are no pending issues between Rubus Realty Company and Furr's Supermarkets, Inc.

12. Throughout the Bankruptcy of Rubus Realty Company, Furr's Supermarkets, Inc. was represented by Jacobvitz & Thuma, and other counsel.

13. The Law Firm of William F. Davis & Assoc., P.C., the predecessor to Davis & Piercc, P.C. never represented Furr's Supermarkets, Inc. in any matter, but was adverse to Furr's

Supermarkets, Inc. in various issues to recover funds from Furr's Supermarkets, Inc. for the benefit of Rubus Realty Company.

14. This Supplemental Disclosure is filed to clarify that Rubus Realty Company was the successor in interest to Furr's, Inc. Furr's Supermarkets, Inc. was another company formed in 1990, which has never been represented in any matter by Davis & Pierce, P.C.
