Peter, and photographer, Ann Hermes, with the Honorable Robert C. Brack. Cameras, photography and videography equipment are permitted in the Guadalupe Courtroom, located on the fourth floor; with the understanding that no defendant will be photographed or videotaped; and, in Judge Brack's Chambers, located on the fifth floor.

No photography and/or videography will be allowed in any part of the courthouse outside of these guidelines.
