**ORDER**

With the concurrence of the Article III judges in the District, this Administrative Order is entered for the Court.

**IT IS ORDERED** that all new cases involving wiretap matters shall be assigned in an equitable and impartial manner, and handled in a manner consistent with the assignment of all other case types within this District.


**IT IS FURTHER ORDERED** that the United States Attorney's Office contact the Clerk's Office as soon as possible to provide notification of a new wiretap matter. The Clerk's Office will assign a judge and a case number for handling said matter and will notify the United States Attorney's Office of the judge assignment and case number.

**IT IS FURTHER ORDERED** that the United States Attorney's Office shall contact the assigned judge to schedule an appropriate date and time to meet and review the wiretap matter.

**IT IS FURTHER ORDERED** that the United States Attorney's Office shall provide a copy of the Wiretap application, and all other relevant documents, to the assigned judge at least three (3) days prior to the scheduled meeting, unless alternate arrangements have been agreed upon.
